

Administration I: Programs in Early Childhood Education

Course Description

Introduction to the administration of early childhood programs. Covers program types, budget, management, regulations, laws, development and implementation of policies and procedures. Examines administrative tools, philosophies, and techniques needed to organize, open, and operate an early care and education program that is responsive to the needs of the community.

SLOs

Objectives

1. Compare and contrast various program structures, philosophies and curriculum models as the foundation for early childhood education program development and administration within and across sites.
2. Describe the range and the types of laws, regulations, policies and procedures applicable to early childhood education program operations and program types.
3. Demonstrate effective procedures for maintaining the business-related operations and fiscal processes for an early childhood education setting.
4. Develop policies for effective staffing and staff scheduling, in accordance with applicable regulations and/or local policies and procedures.
5. Evaluate programs using a variety of methods and tools to establish goals and develop improvement plans.
6. Identify, address, and monitor issues of diversity, inclusion, equity and access within early childhood education programs and settings.
7. Demonstrate how to represent the program effectively to families, the community, funding and oversight agencies, and others.
8. Model ethically responsible, culturally- and linguistically-sensitive conduct and interactions with children, staff, families, and the community as related to program administration
